City of Sublimity Ballot Measure

On July 11, 2022 the Sublimity City Council voted to refer the question to the voters for the following measure:

City of Sublimity Ballot Measure 24-264

CAPTION: Prohibits psilocybin-related businesses within the City of Sublimity.

QUESTION: Shall the City of Sublimity prohibit all psilocybin-related businesses within the City?

SUMMARY: State law permits persons licensed, controlled and regulated by the State to legally manufacture psilocybin products and provide psilocybin services to persons 21 years of age and older. Psilocybin is the psychedelic drug found in certain mushrooms. State law authorizes the governing bodies of cities and counties to adopt ordinances to be referred to the voters that prohibit the establishment of psilocybin product manufacturers and psilocybin service center operators within the area subject to the city or counties jurisdiction. The City of Sublimity is referring to the voters an ordinance prohibiting psilocybin product manufacturers and psilocybin service center operators within the City.

Approval of this measure would prohibit the establishment of psilocybin product manufacturers and psilocybin service center operators within the area subject to the City of Sublimity's jurisdiction.

Explanatory Statement:

Approval of this measure would prohibit the establishment and operation of psilocybin-related businesses within the City of Sublimity.

In November 2020, Oregon voters approved Ballot Measure 109, known as the Oregon Psilocybin Service Act, and now codified in Oregon Revised Statutes (ORS) Chapter 475<u>A.</u> That act allows the manufacture, delivery, and administration of psilocybin at facilities licensed by the Oregon Health Authority (OHA).

OHA has initiated a rulemaking process to implement the State's psilocybin program but has not yet completed that process. The uncompleted rulemaking leaves uncertainty in how the manufacture, delivery, and administration of psilocybin at licensed psilocybin facilities will operate within the City of Sublimity.

ORS 475A.718 authorizes the City Council to refer an ordinance prohibiting psilocybin product manufacturers and psilocybin service centers within the City of Sublimity's jurisdiction and the City Council desires to refer this prohibition to the voters.
