# BACKFLOW TESTING REMINDER FOR UNDERGROUND SPRINKLERS It is required by both State and Local law to have your backflow assembly tested annually.

Now is a good time to start thinking about getting an inspection scheduled for your home. If you have a backflow prevention assembly (lawn sprinkler system) on your property, please do your part to ensure a safe drinking water supply for yourself and everyone in Sublimity.



## Deputy's Corner



As spring approaches and it becomes time to drag out the boats, RV's and other types of recreational toys, I wanted to remind everyone that the City of Sublimity does have a parking ordinance to include the Oregon Revised Code. Not that I am the "parking police" but if anything, just follow the laws and rules of the road and be a good neighbor; park your cars in the correct manner and everyone will be happy. Below is the reminder notice that will be placed on vehicles, boats, trailers, RV's that are in violation. Again, this will be a courtesy warning notice and if not moved within the 72 hours or moved in violation of the ORS, a citation will be issued to the vehicle's registered owner.

#### **ATTENTION**

This vehicle is in violation of the noted Sublimity Municipal Code or Oregon Revised Statue and subject to immediate citation and tow at the owner's expense

\_\_\_\_ 338.17 Sublimity Municipal Code: Storing motor vehicle on streets

No person shall park or store, or permit to be parked or stored, any bus or vacation house, trailer, RV, camper, boat and/or boat trailer, motor home, tent trailer, utility trailer, personal property, or any motorized or unmotorized vehicle which said person owns or has control of on a street or any parking strip, avenue or public way within the city for no longer than 72 hours. Failing to move a motor vehicle or other personal property for 72 hours constitutes prima facie evidence of storage.

\_\_\_\_338.18 Sublimity Municipal Code: Method of parking

No person shall park or stand a vehicle other than the direction of the traffic flow and in such a manner that the front tire closest to the curb is located within twelve inches of the curb.

338.20 Sublimity Municipal Code: Prohibited practices

No operator shall park a vehicle, and no owner shall allow a vehicle to be parked, on a street or other public property for the principal purpose of:

Displaying the vehicle for sale.

Repairing or servicing the vehicle, except while making repairs necessitated by an emergency.

Selling merchandise from the vehicle, except when authorized and permitted.

ORS 811.555 Improperly positioning a parallel parked vehicle

- (A) Upon a two-way highway, the vehicle shall be positioned so that the right-hand wheels are parallel to and within 12 inches of the right curb or, if none, as close as possible to the right edge of the right shoulder.
- (1) The provisions of this section do not apply to the driver of a vehicle that is disabled in such manner and to such extent that the driver cannot avoid stopping or temporarily leaving the disabled vehicle in a position prohibited by this section.
- (2) The offense described in this section, improperly positioning a parallel parked vehicle, is a Class D traffic violation

### Frequently asked Questions at City Hall

Along with City Ordinance, you should always check with your CCR's before building accessory structures or parking a recreational vehicle in your driveway. CCR's take precedence over the City Ordinances.

<u>Lost and Found:</u> City Hall has a lost and found. If you have lost something in one of the City parks, be sure to check with City Hall to see if it has been turned in. If you find that someone has left a belonging behind, you can turn it in to City Hall.

**Backflow Devices:** Backflow devices must be tested annually. A list of backflow inspectors can be found on the City website or at City Hall.

<u>Building a fence</u>? Please make sure you contact City Hall for a permit. Although there is no fee to build a fence, the city does have codes that need to be followed and they require approval.

Building a storage shed? Sheds under 200sq feet do not require a permit. If you are

building anything bigger you must get a structural permit from the city and follow city codes.

<u>Parking on Street:</u> NO Parking of Cargo Trailers, RVs, Boats or any vehicle of any type is allowed on the street for more than 72 hours.

Garage Sales: You are required to obtain a \$5.00 permit from City Hall before having a garage sale.

<u>Pets:</u> Pets are required to be kept on leash at all times while in city parks. Pet owners are required to clean up after their animals. Mutt Mitts are available in the parks.
